## Declaration of Compliance to REACH

REACH – European Regulations for Registration, Evaluation, Allowance and Restriction of Chemical Materials (Regulation (EG) No. 1907/2006)

Dear Sirs,

many of our customers ask for information if our products (boards) are affected by the REACH regulation, and if they are to what extent.

### We can make the following statements on that:

REACH makes a difference especially between the following categories, which are important for our products: materials, polymers, formulations and products. A material is e.g. formaldehyde. A polymer is e.g. urea-formaldehyde-glue and a product is e.g. a particleboard. Normally, only the registration of materials and partly formulations is mandatory, the registration of polymers and products not.

According to REACH we have the status of an in-line user for the production of our products. The glues that are used for the board production are all polymers and are not subject to registration according to the REACH regulation.

We neither produce nor sell basic materials, which are used for the glue production. The materials used in the subsequent processing in our products are pre-registered. So they can be continuously used. Declarations of the pre-registration are made available to us by our suppliers.

The particleboards, fibreboards and OSB boards as well as the secondary products coated with melamine films and glue impregnated papers for the coating are products in the sense of the REACH regulations. The ingredients of our products are not released deliberately.

That is why we are not subject to the registration or notification requirements according to the REACH regulations.
